Explanation of Services:

- A. Canine Connections, LLC (Canine) shall exercise reasonable care to maintain a clean, safe and secure environment for the dog while in Canine's care. The dog shall be fed properly and regularly; shall be housed in it's own quarters; shall be brushed, cleaned and groomed as needed and shall not be allowed off of Canine's premises without the consent of the owner(s).
- B. If training is included under this contract, the dog will be trained to perform as shown by demonstration. Included in the training shall be training sessions with the owner(s). Owner(s) understands and agrees that, should the owner fail to cooperate fully in completing the owner training sessions Canine cannot and does not assume or accept responsibility for the behavior or performance of the dog after it has been returned to the owner(s). If owner(s) cooperates fully in the training sessions, Canine will provide, without cost, within the six (6) month period following such training sessions, such follow-up sessions with the dog and owner(s) or handler as may be needed.
- C. If the dog shows evidence of a medical problem while under the care of and control of Canine, Canine shall have the right to take such measures as it deems necessary, without being liable to the owner(s) for the health and safety of the dog, including the right to administer medication or obtain an evaluation and treatment by a veterinarian of Canine's choice. If, in the opinion of Canine or the veterinarian selected by Canine, the cost of treatment will exceed the amount of seventy-five dollars (\$ 75.00), reasonable attempts will be made to contact the owner(s), and/or the veterinarian designated by owner(s), above, for further instructions. In the event that owner or designated veterinarian cannot be contacted, Canine or the veterinarian selected by Canine may, without liability to owner(s), provide such emergency medical treatment as deemed necessary to preserve the life and health of the dog. Owner(s) shall pay the cost of all treatment of provided for in this paragraph, in addition to the contract price, prior to the dog being picked up by the owner(s)
- D. If, during the training of the dog, the training is interrupted for any reason not the fault of Canine, including the illness of the dog, the owner(s) may at the owner's option, continue to board the dog at Canine at its then existing boarding rate until training can be continued. Such boarding cost shall be in addition to the contract price. Otherwise, the owner(s) may pay any balance due to the contract price and remove the dog from Canine's premises, in which case the dog may be returned to Canine at a later time for completion of training at no additional cost. If any delay or interruption of training is the fault of, or at the request of Canine, including delays for stress which may show up during training, owner shall not be charged for any such delay or interruption.
- E. Canine agrees that, while the dog is on its premises and under its control for boarding or training, Canine will exercise the utmost diligence and care to protect the health and safety of the dog. However the owner(s) agrees that Canine has not liability for loss or damage to the dog or owner's other property as the resulting from fire, disease, illness, virus, escape, theft, death or other unavoidable causes. After the dog has been returned to the owner(s) by Canine, and is off Canine's premises, Canine cannot and does not accept any responsibility for the illness, injury or death of the dog or of any person or animal, or damage to any property, caused by the dog.
- F. If at the completion of the agreed boarding or training time, the dog is not picked up by the owner(s) and payment of all charges made in full including applicable medical, veterinarian or boarding charges as provided herein, Canine shall notify the owner by certified mail at the address shown above that the dog will be held for an additional ten (10) days following the date of mailing the notice. At the end of the ten (10) day period, if there is no response from owner(s), the dog may be sold at public or private sale. The proceeds of such sale shall be first applied to the charges of Canine and the balance, if any, shall be returned to owner at the address shown above. Owner(s) shall be charged for any such additional days following notice at Canine's then existing daily boarding rate.

Owner(s) represent that owner(s) is/are the legal owner(s) of the dog; that the dog is free and clear of any mortgage or other encumbrance; that the dog has not been exposed to distemper, rabies or parvo within the last thirty (30) days; that the dog has been inoculated as shown above; that the dog is currently and properly licensed; and that the owner has read this agreement in its entirety.
